INTERLOCUTORY ORDER

An ex parte hearing having been held this day on 28 applications made purusant to 42 U.S.C.A. 1971(e) for orders of qualification to vote in East Carroll Parish, Louisiana, all received by this Court between July 31, and August 6, 1962, the Court makes the following findings based upon the record in this case, the applications for orders of qualification, the affidavits of disposition towards the laws of Louisiana, the registration application forms, the writing tests, the citizenship tests and the oral testimony of the applicants:

- 1. Defendant Cecil Manning, the Registrar of Voters for East Carroll Parish, Louisiana, resigned his office on June 14, 1962, and no successor has been inducted into office to perform the duties of Registrar of Voters in the aforesaid Parish.
- 2. Each applicant whose name appears on List A, which is attached hereto and made a part hereof:
 - (a) Is a member of the Negro race,
 - (b) has since May 30, 1962, been deprived and denied of the opportunity to register to vote or otherwise to qualify to vote in East Carroll Parish, Louisiana, by virtue of the vacancy in the office of the Registrar of Voters; within the meaning and intent of 42 U.S.C.A. 1971(e),

- (c) is qualified under Louisiana Law to vote in East Carroll Parish, Louisiana.
- 3. Each applicant whose name appears on List B, which is attached hereto and made a part hereof:
 - (a) is a member of the Negro race,
 - (b) has since May 30, 1962, been deprived and denied of the opportunity to register to vote or otherwise to qualify to vote in East Carroll Parish, Louisiana, by virtue of the vacancy in the office of Registrar of Voters; within the meaning and intent of 42 U.S.C.A. 1971(a),
 - (c) is not presently qualified under Louisiana Law to vote in East Carroll Parish, Louisiana.
- 4. No finding is made with respect to David Lee Washington because he did not appear at this hearing; his application for an order of qualification will be dismissed without prejudice.
- 5. Based upon these findings it is the conclusion of this Court that the persons whose names appear on List A have met the requirements of 42 U.S.C.A. 1971(e) and are entitled to vote in elections in East Carroll Parish, Louisiana, as if they had been registered to vote by local registration officials. This includes, for those who have declared their affiliation with the Democratic party, the Democratic primary election to be held on September 1, 1962. This Order should be made final prior to that election. Before this Order is made final, all parties will have an opportunity to file exceptions to these findings and conclusions and will have an opportunity to be heard on these exceptions. Once a final order is emtered, the only remedy available to any party who feels aggrieved is to appeal.

In accordance with these findings and conclusions:

IT IS HEREBY ORDERED that each person whose name appears
on List A is declared qualified to vote in East Carroll Parish in
all elections, including the Democratic primary election scheduled
to be held on September 1, 1962, to the same extent as if such

person had been registered to vote by local registration officials.

The Clerk shall prepare a Certificate of Qualification for each such person and it is to be available to the Court on <u>Guarantee</u>

IT IS FURTHER ORDERED that the persons whose names appear on List B are not presently qualified to vote in East Carroll Parish and their applications to do so are denied.

IT IS FURTHER ORDERED that the application of David Lee Washington for an order of qualification is hereby denied without prejudice.

IT IS FURTHER ORDERED that the Attorney General of the United States shall, no later than August 10, 1962, serve upon the Attorney General of the State of Louisiana and upon the District Attorney for the 6th Judicial District of Louisiana copies of this order, together with copies of each application, all documents written or filled out by the applicants at the hearing and a transcript of all oral testimony taken at the hearing. The Clerk shall make available to the representatives of the Attorney General of the United AStates all documents and papers on file in this case so that copies for service can be made.

on <u>August 20,1962</u>, unless exceptions are filed and served on or before <u>August 17,1962</u>, in the manner and form prescribed by 42 U.S.C.A. 1971(e) for filing exceptions to the report of a voting referee. Such exceptions shall be served upon the attorneys of record of the parties to the original action. In the event exceptions are filed, a hearing will be had thereon at the United StatesCourthouse and Post Office Building in Shreveport, Louisiana, on <u>August 20,1962</u> at 9:30 A M

Provided no exceptions are filed by <u>August 17,1962</u>, the United States Marshal shall serve on or before September 1, 1962, a copy of this Order upon each election official in East Carroll Parish.
