

He tells a story of almost 100 years of life in an almost all-black parish where Blacks seemed to thrive mostly in isolation from whites yet since Reconstruction, no Blacks had been allowed to vote. Cleo's father, a little known minister and farmer, took his fight to Washington where his 1962 win for voting rights opened doors for many more to also begin voting, teaching others the power of ordinary people who decide they will not accept things as they have always been.



HOT TOPICS/QUESTIONS

GENERAL

- Your background is risk management. How did you come to write this historical account?
- Tell us about your latest project on race and religion.



PERSONAL EXPERIENCES IN THE JIM CROW SOUTH

- Many issues are covered in 100 years of "Witness to the Truth". What are some principal issues addressed?
- Tell us about your home in the majority-black Louisiana delta. How was it different from many other places?
- Your book says your dad was raised by people who lived during slavery. How could that be and what did he say that was like?
- You wrote a post on LinkedIn called "OMG! The Last Jim Crow Generation is In Charge!" What was Jim Crow and why was it more dangerous to grow up toward the end of that era? How has unaddressed issues impacted today?

VOTING RIGHTS & WRONGS

- Black people in much of the South were not allowed to vote until the late 1960s. How were they prevented from voting if the 15th Amendment said that people couldn't be denied the right to vote based on race?
- How did your area get the right to vote before much of the south, without major protests?
- You and your family suffered many retaliations for your parents trying to vote. What was that like for a child and how has it informed your writing?
- Many people take their right to vote for granted. Why is voting so important that people will deceive and even kill people to keep them from voting?
- How did the 1965 Voting Rights Act solve most of the voting issues for Black people?
- What has happened since the 2013 Supreme Court decision gutting the Act?
- What can be done to fix the problem?
- How do you feel looking at voting rights as they stand now?

HAVING PRODUCTIVE CONVERSATIONS ABOUT RACE

- You were involved in doing critical race-related work in Charleston after the massacre at Mother Emanuel. What are some valuable lessons you learned about having conversations?
- Share your experiences at the CRT Ban hearings and what you learned.
